### COUNCIL DISCUSSION

SD1 Sewer Lateral Program - Mr. Ziegler said the City of Erlanger still plans to file a lawsuit against SD1 plus seven other cities plan to join. Kenton County is considering joining the suit. The City of Lakeside Park signed the agreement with SD1. When SD1 took over the maintenance it included the laterals. The cost to join the lawsuit will not exceed \$2,500.

Mrs. Rose made a motion to join the City of Erlanger in the lawsuit against SD1. A second was offered by Mr. Rice. After asking for discussion or questions, Mayor Hehman called for a roll call vote.

### DISCUSSION OF STAFF IDEAS

Economic Development – Mrs. Reddy.

- Problems
  - Traffic issues on Dixie Highway
  - Currently City has no incentives to offer new businesses
    - Need to develop a formal document
    - Can include amenities such as memberships to the County Club or gym
- Update
  - o Drawbridge Site
    - Christ will focus on site this year
    - Will move forward with the TIF Tax Incremental Financing
    - Need a development plan
    - Bayer Becker is doing a traffic study
  - O Buttermilk and Orphanage realignment
    - Traffic
      - Very heavy
      - Backups happen regularly
      - 60% of the time traffic flow not working
      - Need to discuss with legislators.
        - The first step was to document issue This has been completed with help from PDS

# Administration - Mrs. Reddy

- Communication and Outreach
  - Fort Mitchell Living Magazine
    - Possibility of publishing a Fort Mitchell newsletter in the magazine every quarter.
  - Caucus Meeting
    - Held few second council meetings in 2015
    - More beneficial to hold quarterly meetings to focus on specific topics

## Fire - Chief Auffart

- Need to increase training and staff members
- Submitted a report covering ten years See Attachment #3

## Police – Acting Chief Robinson

- New Teams
  - Special Enforcement Team
    - Plain Clothes Detail to work on problems such as drugs and break-ins
  - Neighborhood Action Teams
    - Teach how to spot drug users
    - Develop ideas
    - Get involved with kids at Beechwood
  - o Intel Base Policing Customized analytical Dashboards

- Covington purchasing the Atacraids/Blair We can piggyback with them. See attachment # 4
- New Radios
  - Kenton County Dispatch changing equipment.
    - o Will require Police and Fire to purchase new radios
      - Cost approximately \$200,000

### Recreation - Recreation Coordinator Zach Rechtin

- Will hold office hours on Tuesdays and Thursdays 8:00 am to noon
- Upcoming Events
  - Will follow Recreation Committee Report on the events to continue
  - o All events will have an on-line registration and payments if needed
  - Recreation Committee will hold monthly meetings

  - Requested Recreation Committee members volunteer or find volunteers to help with events
  - During signups list volunteer opportunities

# Parks - Director Kyle Bennett

- Beechwood request for a track in Park Mayor Hehman
  - Mr. Hayes reviewed the plans and cost
  - Council members discussed that the cost was too high
    - Chief Auffart suggested contacting the Cincinnati Bengals as a potential source of funding
- Park Board plans to improve park
  - Reviewed three possible plans to improve
    - See Attachments #5
  - Will install WiFi in General Ormsby Park
    - Highly requested in the public survey
  - Residents definitely want a walking trail

# Public Works - Mrs. Reddy

- Sidewalks
  - Currently
    - Replace if needed during a large road construction project
    - MRA can be used for sidewalks
  - o Future
    - Possibly cost share
    - Identify areas and bid out
  - Orphanage Road
    - Grant request for sidewalks turned down
    - \$150,000 currently in budget
    - Engineering complete
    - Sidewalks there could be dangerous
    - Invite property owners to a Council meeting to discuss in March

# Finance - Mrs. Guenther

- Outcome Based Budgeting
  - Will try this with the upcoming budget with a few items

# Other - Mr. Reis

- City Beautification
  - o Islands in front of Kroger's and I-75 ramps
  - Landscaping around City
  - o Tie all together
    - Consider sign/wall in front of Mercedes
