

**FORT MITCHELL CITY COUNCIL
REGULAR MEETING
July 18, 2016**

CALL TO ORDER / PLEDGE OF ALLEGIANCE / ROLL CALL

Mayor Hehman called the meeting to order at 7:00 pm followed by the Pledge of Allegiance. He then thanked the police officers for protecting our community every day. Mayor Hehman called for a moment of silence for the police officers in Baton Rouge and Dallas who lost their lives this week in the line of duty.

Fire Chief Gary Auffart introduced Jeff Hampton. He was promoted to Fire Lieutenant today. His wife and daughter accompanied him. Lt. Hampton stated he was very grateful for the opportunity.

COMMUNITY INVESTMENT AWARD

Mayor Hehman announced the winners of the first Community Investment Award. They are W. Stephens Cabinetry & Design, Dr. Ryan Olexia Fort Mitchell Veterinary Center and Alex Edmondson. Mr. Stephens was present and expressed his thanks to the Mayor and Council.

CITY ATTORNEY'S REPORT

Mr. Ziegler performed a second reading of Ordinance 2016-08 for a Text Amendment amending Sections 10.12, 10.13, 10.14 and 10.16 of the Fort Mitchell Zoning Ordinance. Mr. Hayes made a motion to adopt Ordinance 2016-08 for a text amendment. Mrs. Nachazel offered a second. Mayor Hehman called for any questions or further discussion and upon hearing none, he called for a roll call vote.

MAYOR'S REPORT

Mayor Hehman stated the Fourth of July Parade was great this year! We will honor the winners at the next Council meeting.

Mayor Hehman announced this is an election year and he asked Council Members to consider running again. It has been a good year and a half, but we have more work to do.

CITY ADMINISTRATOR'S REPORT-SHARMILI REDDY

Mrs. Reddy said she has worked in Fort Mitchell now for one year. She thanked the department heads and staff for the work they do everyday. Thanked the Mayor for his daily support and council members for the ongoing support.

- A letter was mailed to the residents near the Buttermilk/Orphanage Road project.
- A copy of the proposed park survey was handed out tonight to Council. The survey will be mailed in late August.
- The flag lots in Fort Mitchell will be reviewed in September. Mrs. Reddy, Mr. Stegman and Mrs Boerger met with PDS to begin the discussion.
- Still working with SDI on the private sewer laterals. The Mayors and County Judges met and agreed to add \$350,000 to the budget for the laterals.
- Thanked Linda Bartels for the excellent work in renewing our employee health insurance this year. There will not be an increase in cost.

DEPARTMENT HEAD REPORTS

Administration – Linda Carter, City Clerk

- Reviewed the recent trash bid results. The bids were still high for the service. Mrs. Reddy said per a survey on Facebook, the citizens preferred once a week pickup instead of our current two times per week. Mayor Hehman said we could sign a one year contract and bid again next year with the City of Lakeside Park. Council suggests trying one time per to see how it works, stay with the same company (Best Way) and reevaluate at the end of the year.

Mrs. Rose made a motion to select Best Way as the waste/recycling hauler for the next year. Mrs. Nachazel offered a second. Mayor Hehman called for any questions or further discussion and upon hearing none, he called for a roll call vote.

Police – Andrew Schierberg, Police Chief

- They are review body cameras and will continue to keep everyone updated.
- Joel Tignor will be returning to Fort Mitchell tomorrow.

Fire – Gary Auffart, Fire Chief

- Thanked Mayor and Council for the raises for the public safety employees
- Steve Greis and Todd Klier are retiring this month. The department is struggling to hire good employees. They do not like the long hours, want more time with family and more opportunities.

Recreation – Zach Rechtin, Recreation Coordinator

- Movie night a big deal this year. A movie screen and quality sound system was donated. There will be healthy food and drinks.
- A comprehensive report will be out by the end of August.

Finance – Amy Guenther, City Treasurer

- Sent out a Request for Proposals for an auditor. She contacted all finance officers in the area and request names of auditors. Ask Council Members to send her names also.

Public Works - Matt Stegman, Public Works Director

- This was his first year to work the parade and thought it was great. The coordination was excellent. He enjoyed the parade and is proud to work for Fort Mitchell.
- The underpass between Blessed Sacrament and Burdsall is now cleaned up. With the help of volunteers there is now new paint and lights.

EXECUTIVE SESSION

Mrs. Rose made a motion to go in to executive session - pursuant to KRS 61.810(1)(f), Discussions or hearings which might lead to the appointment, discipline or dismissal of an individual employee, member, or student without restricting that employee's, member's, or student's right to a public hearing if requested. This exception shall not be interpreted to permit discussion of general personnel matters in secret. Mr. Stoeckle seconded the motion. After asking for discussion or questions and hearing none, Mayor Hehman called for a voice vote. The motion carried by all ayes. Motion passed. The council moved in to executive session at 8:04 pm.

Mrs. Boerger made a motion to come out of executive session at 8:32 pm. Mr. Stoeckle seconded the motion. After asking for discussion or questions and hearing none, Mayor Hehman called for a voice vote. The motion carried by all ayes.

Mayor Hehman announced we received two proposals for a City Attorney. There was one from Rob Ziegler and one from Louis Kelly. After careful review and consideration, the selection was made. Mr. Stoeckle made a motion to select Louis Kelly of Adam, Stepner, Woltermann and Dusing as our new City attorney. Mrs. Rose offered a second. Mayor Hehman called for any questions or further discussion and upon hearing none, he called for a roll call vote.
