

ORDINANCE 2016-10

AN ORDINANCE OF THE CITY OF FORT MITCHELL, KENTUCKY, LEVYING A TAX OF \$0.02 ON EACH ONE HUNDRED DOLLARS (\$100.00) OF ASSESSED VALUATION OF PROPERTY IN THE CITY, FOR THE FISCAL YEAR 2016-2017 FOR THE PURPOSE OF PURCHASING AND MAINTAINING PUBLIC PARKS.

BE IT ORDAINED BY THE CITY OF FORT MITCHELL, KENTUCKY:

SECTION I

In addition to the general ad valorem tax levied and imposed by the City of Fort Mitchell, Kentucky, pursuant to applicable Ordinance and pursuant to authority of Kentucky Revised Statute 97.590, an additional ad valorem tax is hereby assessed and levied for the fiscal year 2016-2017 against all real property within the corporate limits of the City of Fort Mitchell, Kentucky, at the rate of \$0.02 on each One Hundred Dollars (\$100.00) of valuation, to be collected as proved by law and by existing ordinances of the City of Fort Mitchell, Kentucky.

SECTION II

This ad valorem tax is levied solely for the purpose of purchasing and maintaining public parks within the City limits of the City of Fort Mitchell, Kentucky.

SECTION III

All funds derived from the within tax levy shall be held and maintained by the treasurer of the City of Fort Mitchell, Kentucky in a separate and distinct fund designated as the "Park Fund" and disbursements from said funds shall be made only for the purposes as aforesaid.

SECTION IV

The City of Fort Mitchell, Kentucky, shall have a lien upon all property upon which ad valorem taxes are hereby levied for payment of said taxes, and for all penalties, interest, fees, commissions, charges and other expenses including court costs and attorneys' fees incurred by reason of any delinquency in payment of such taxes, or in the process of collecting them and such lien has priority over all other obligations or liabilities for which the property is liable.

SECTION V

All Ordinances or parts of Ordinances in conflict herewith are, to the extent of such conflict, in any, hereby repealed.

SECTION VI

The provisions of the Ordinance are severable and the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions shall remain in full force and effect as long as they remain valid in the absence of that provision determined to be invalid.

SECTION VII

This Ordinance shall be in full force and effect from and after its passage and publication according to law.

SUMMARY OF CITY ORDINANCE 2016-10:
PARK TAX RATE

This summary is made pursuant to the authority of KRS 83A.060(9), which permits the City to publish a summary of an Ordinance in lieu of the publication of the full Ordinance itself. Said summary follows:

A. The title of the Ordinance is: AN ORDINANCE OF THE CITY OF FORT MITCHELL, KENTUCKY, LEVYING A TAX OF \$0.02 ON EACH ONE HUNDRED DOLLARS (\$100.00) OF ASSESSED VALUATION OF PROPERTY IN THE CITY, FOR THE FISCAL YEAR 2016-2017 FOR THE PURPOSE OF PURCHASING AND MAINTAINING PUBLIC PARKS.

B. The Authority for the Ordinance is KRS 97.590.

C. The Ordinance sets forth the following sections:

1. In addition to the general ad valorem tax levied and imposed by the City of Fort Mitchell, Kentucky, pursuant to applicable Ordinance and pursuant to authority of Kentucky Revised Statute 97.590, an additional ad valorem tax is hereby assessed and levied for the fiscal year 2016-2017 against all real property within the corporate limits of the City of Fort Mitchell, Kentucky, at the rate of \$0.02 on each One Hundred Dollars (\$100.00) of valuation, to be collected as proved by law and by existing ordinances of the City of Fort Mitchell, Kentucky.

2. Provides that the tax is levied solely for purchasing and maintaining parks.

3. Provides that funds from this tax levy shall be held in a separate fund called "Park Fund."

4. Provides that the City shall have a lien upon all property subject to this tax for payment of said tax, including for penalties, interest, and fees related to delinquency.

5. Repeals conflicting ordinances.

6. Provides that the provisions are severable..

7. Provides that the ordinance takes effect upon publication.

D. The Ordinance becomes effective upon final reading and publication, with final reading and passage having been on September 22, 2016.
