

ORDINANCE 2016-13

**AN ORDINANCE ENACTING AND ADOPTING A
SUPPLEMENT TO THE CODE OF ORDINANCES OF THE
CITY OF FORT MITCHELL, KENTUCKY AND
DIRECTING THIS ORDINANCE BE PUBLISHED BY
SUMMARY**

WHEREAS, pursuant to KRS 83A.060(11) American Legal Publishing Corporation of Cincinnati, Ohio has completed a Supplement to the Code of Ordinances of the City of Fort Mitchell, Kentucky, which supplement contains all ordinances of a general nature enacted since the enactment of Ordinance 2014-11 to the Code of Ordinances of this City; and

WHEREAS, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make references to sections of the Kentucky Revised Statutes; and

WHEREAS, said American Legal Publishing Corporation has recommended the elimination of redundant, obsolete, inconsistent and invalid provisions in the City's Code of Ordinances; and

WHEREAS, it is the intent of Council to accept these updated sections in accordance with the law of the Commonwealth of Kentucky;

NOW THEREFORE, BE IT ORDAINED by the City of Fort Mitchell, Kentucky as follows:

SECTION I

That the Supplement to the Code of Ordinances of the City of Fort Mitchell, Kentucky as submitted by American Legal Publishing Corporation of Cincinnati, Ohio and as attached hereto, be and the same is hereby adopted by reference as if set out in it entirety.

SECTION II

All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, if any, hereby repealed.


SECTION III

This summary is made pursuant to the authority of KRS 83A.060(9), which permits the City to publish a summary of an Ordinance in lieu of the publication of the full Ordinance itself. Said summary follows:

A. The title of the Ordinance is: AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES OF THE CITY OF FORT MITCHELL, KENTUCKY AND DIRECTING THIS ORDINANCE BE PUBLISHED IN SUMMARY.

B. The Authority for the Ordinance is KRS 83A.060.

C. The Ordinance sets forth the following sections:

1. Adopts a Supplement to the Code of Ordinances as submitted by American Legal Publishing.

2. Repeals conflicting ordinances.

3. Provides that the ordinance takes effect upon publication.

4. Provides that the Ordinance shall be published by summary.

D. The Ordinance becomes effective upon final reading and publication, with final reading and passage having been on September 19, 2016.
