

ORDINANCE 2017-13

AN ORDINANCE AMENDING CHAPTER 74 OF THE CITY OF FORT MITCHELL CODE OF ORDINANCES TO MODIFY TWO HOUR PARKING ON THE NORTH BOUND PORTION OF DIXIE HIGHWAY BETWEEN ORPHANAGE ROAD AND 2479 DIXIE HIGHWAY TO 30 MINUTES.

Whereas, the City Council of the City of Fort Mitchell has determined that it is in the public interest to limit parking to 30 minutes on the southeast side of Dixie Highway between Orphanage Road and 2479 Dixie Highway.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF FORT MITCHELL, KENTUCKY:

SECTION I

Schedule VI and Chapter 74 of the City of Fort Mitchell Code of Ordinances are hereby amended to:

SCHEDULE VI. PARKING TIME LIMITS.

No vehicle shall park in the following locations for longer than the time specified ~~from 10:00am to 7:00 p.m. or 8:00pm~~ depending on location described below. Portions not listed in this section shall have no parking time restrictions unless specifically provided for in this Chapter.

<u>Street</u>	<u>Location</u>	<u>Time Limit</u>
Dixie Highway	<u>North bound portion between Orphanage Road and Requardt Lane and 2479 Dixie Highway</u>	<u>2 hours from 10:00 a.m. to 8:00 p.m.</u>
	<u>North bound portion between 2479 Dixie Highway and Orphanage Road</u>	<u>30 minutes from 10:00 a.m. to 7:00 p.m.</u>

SECTION II

All Ordinances or parts of Ordinances in conflict herewith are, to the extent of such conflict, if any, hereby repealed.

SECTION III

The Provisions of this Ordinance are severable and the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions

shall remain in full force and effect as long as they remain valid in the absence of that provision determined to be invalid.

SECTION IV

This Ordinance shall be in full force and effect from and after its passage and publication according to law, and said publication may be in summary form.

**SUMMARY OF CITY ORDINANCE 2017-13:
THIRTY MINUTES PARKING ON CERTAIN PORTIONS OF DIXIE HIGHWAY**

This summary is made pursuant to the authority of KRS 83A.060(9), which permits the City to publish a summary of an Ordinance in lieu of the publication of the full Ordinance itself. Said summary follows:

A. The title of the Ordinance is: AN ORDINANCE AMENDING CHAPTER 74 OF THE CITY OF FORT MITCHELL CODE OF ORDINANCES TO MODIFY TWO HOUR PARKING ON THE NORTH BOUND PORTION OF DIXIE HIGHWAY BETWEEN ORPHANAGE ROAD AND 2479 DIXIE HIGHWAY TO 30 MINUTES.

B. The Authority for the Ordinance is KRS 82.082.

C. The Ordinance sets forth the following sections:

1. Limits parking on the north bound portion of Dixie Highway between Orphanage Road and 2479 Dixie Highway to 30 minutes from 10:00am to 7:00pm.

2. Repeals conflicting ordinances.

3. Provides that the provisions of the Ordinance are severable.

4. Provides that the ordinance takes effect upon publication and shall be published by summary.

D. The Ordinance becomes effective upon final reading and publication, with final reading and passage having been on July 17, 2017.
