



REQUEST FOR BIDS – FIRE DEPARTMENT VEHICLE

The City of Fort Mitchell is accepting sealed bids for the purchase of one (1) vehicle for use by the Fort Mitchell Fire Department **with an optional purchase of a second vehicle with the same specifications. Sealed bids marked “Fire Vehicles” and shall be delivered to the attention of Amy Guenther, City Clerk, City of Fort Mitchell, 2355 Dixie Highway, Fort Mitchell, Kentucky 41017 by 10 a.m. on April 27, 2021**, at which time the bids will be opened publicly in Council Chambers. The City of Fort Mitchell reserves the right to reject any and all bids, to waive informalities and to negotiate with the apparent qualified best bidder to such extent as may be in the City's best interest.

The below listed minimum qualifications shall be met:

Vehicle Basic Specifications:

Vehicle Year: 2020 or 2021

Vehicle Make: Dodge

Vehicle Model: Durango (Special Service Vehicle or Pursuit Vehicle)

Vehicle Color: White (Note: The only alternative color for consideration is Red)

Vehicle shall be equipped with the following:

- 3.6L V6 24V WT Engine
- Automatic Transmission
- Vehicle shall be All Wheel Drive

Vehicle Delivery:

Bid packages shall include a delivery timeline for the vehicle included in the bid package.

Vehicle Upfitting:

Upfitting shall match closely to existing Fort Mitchell Fire Department vehicle specifications which include:

- Whelen 295SLSA6 Siren/Switch
- Whelen Howler Siren (Preferred for this vehicle)
- Whelen IONP Pedestal Mount – Side Windows
- Whelen TCRHS5 Tracers R/W (Side mounted under doors)
- 8EVP E106 Flat LED – Rear Hatch (R/A/R on both sides with directional capabilities)
- 24" R/W Dual Color Dome -Rear
- ELPF4 R/W Dual color license plate kit – May be substituted with dual color R/A or R/W Ion lights mounted on either side of license plate
- Brooking FL-20RFIP LED Tail Light Flashers
- H-2209 R/W Cannon – Back Up Lights
- Black 800 MHZ Phantom Antenna
- Invertor 1000 Watt (Install location in rear hatch area – final location to be determined during upfitting discussion)
- Soundoff Interior Dome Light
- Radio wiring for 700/800 MHZ dual head Kenwood radio – Main radio mounted in front driver area – Remote head to be mounted in rear cargo area.

Storage Unit (Rear Cargo Area):

An optional rear storage unit/command console may be considered as part of the upfitting package. The vehicle will be used as a fire department command unit. Please include pricing for available storage unit/command consoles with information on design dimensions as well as storage availability. Fire gear will also be stored in the rear compartment area of the vehicle.

Vehicle Lettering Package:

The vehicle lettering package of the existing Fort Mitchell Fire Department vehicle is included on the next page. Lettering on the vehicle if the upfitting option is bid it shall match the attached layout. Please include in the bid package a drawing on a schematic of the vehicle proposed for our review.
