Public Works Director, Nick Tewes


- Crews are patching curb on Dixie Highway.

- The internship is at full capacity with six college interns and 4 high school interns.


ADJOURNMENT

SURPLUS PROPERTY**


Whereas, the City of Fort Mitchell deems that it is in the best interest of the City to surplus the following items selling or donating them to another governmental agency:

- 2012 Dodge Charger Pursuit 2C3CDXAT4CH282358 74,262 miles will be sold for \$2,000 to Perry County Sheriff's Office. This vehicle will be sold due to higher miles and the age of the vehicle.
- 2013 Dodge Charger Pursuit 2C3CDXATXDH713044 75,249 miles will be sold for \$2,000 to Perry County Sheriff's Office. This vehicle will be sold due to higher miles and the age of the vehicle.
- 2014 Dodge Charger Pursuit Vehicle (VIN 2C3CDXAT5EH348404) with 64,183 will be donated to Menefee County Schools. This vehicle needs significant repairs.

Now therefore, in accordance with Fort Mitchell Ordinance 38.01, the City of Fort Mitchell's Purchasing Procedures, and KRS 82.083 and 65.041, the Mayor of the City of Fort Mitchell is authorized to dispose of the aforementioned property.
