#### **ORDINANCE 2022-16**

AN ORDINANCE OF THE CITY OF FORT MITCHELL, KENTUCKY, AMENDING THE GENERAL FUND ANNUAL BUDGET OF THE CITY FOR THE FISCAL YEAR JULY 1, 2022 THROUGH JUNE 30, 2023 AND DIRECTING THIS ORDINANCE TO BE PUBLISHED BY SUMMARY.

Whereas, a General Fund budget amendment for the fiscal year July 1, 2022 through June 30, 2023 has been prepared and delivered to City Council;

Whereas, the City of Fort Mitchell has increased the General Fund revenue and general government expenditures each by \$597,000 for two pass-thru Community Development Block Grants for two nonprofit organizations within the City of Fort Mitchell.

Whereas, the City Council has reviewed such amended budget and made necessary modifications;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF FORT MITCHELL, KENTUCKY:

## **SECTION I**

The General Fund annual budget for the City of Fort Mitchell, Kentucky, for the fiscal year beginning July 1, 2022 and ending June 30, 2023 estimating revenues and resources and appropriating funds for the operation of the City is hereby amended as set forth on the attached Exhibit A and incorporated in this Ordinance by reference. This Ordinance shall be effective immediately.

#### **SECTION II**

All Ordinances or parts of Ordinances in conflict herewith are, to the extent of such conflict, if any, hereby repealed.

#### **SECTION III**

The Provisions of this Ordinance are severable and the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions shall remain in full force and effect as long as they remain valid in the absence of that provision determined to be invalid.

### **SECTION IV**

This Ordinance shall be in full force and effect from and after its passage and publication according to law and said publication may be in summary form.
