# CITY OF FORT MITCHELL KENTON COUNTY, KENTUCKY ORDINANCE 2023-05

# AN ORDIANCE AMENDING A PROVISION OF CHAPTER 74 OF THE FORT MITCHELL CODE OF ORDINANCES RELATING TO TRAFFIC SCHEDULES

WHEREAS, the Fort Mitchell City Council has heretofore adopted official ordinances related to traffic schedules within the City;

WHEREAS, these ordinances are periodically reviewed and updated as needed.

# NOW, THEREFORE BE IT ORDAINED BY THE CITY OF FORT MITCHELL, COUNTY OF KENTON, COMMONWEALTH OF KENTUKCY, AS FOLLOWS:

## **SECTION I**

The following section of Chapter 74 of the Fort Mitchell Code of Ordinances is amended to read as follows:

### SCHEDULE II. PROHIBITED TURNS.

No vehicle shall be permitted to make the turns as listed below at the following locations.

#### SCHEDULE III. DISCHARGING OR PICK-UP OF PASSENGERS PROHIBITED.

No vehicle shall be permitted to discharge or pick-up passengers at the following location.

Along the right-ofway of Idaho Avenue

between Dixie

Highway and Oak Street

Mondays through Fridays, between 7:30 a.m. and 8:30 a.m. and between 2:00 p.m. and 3:00 p.m. during the period of August 15 through June 15 Consistent with designated school drop-off and pick-up times as indicated by signage along both the northbound

and southbound sides of Idaho Avenue.

#### SCHEDULE IV. PROHIBITED PARKING.

No vehicle shall be permitted to park in following location:

Summit Ave. From its intersection with Chelsea Drive to its intersection with Avon Drive

#### SCHEDULE V. STOP SIGNS.

Stop signs shall be placed at the following locations:

Street

Location

Highland

Northeast intersection with Oak Street

Avenue

Highland

Southwest intersection with Oak Street

Avenue

Saint John's Road Four signs at intersection with Kruempelman Drive and Ridge Road, the first sign facing east located on the north side of Saint John's Road and on the east side of Krempelman Drive; the second facing north located on the north side of Saint John's Road and the west side of Kruempelman Drive; the third facing west located on the south side of Saint John's Road and the west side of Ridge Road; and the fourth facing south located on the east side of Ridge Road and the south side of Saint John's Road.

#### SCHEDULE VI. PARKING TIME LIMITS.

No vehicle shall park in the following locations for longer than the time specified depending on location described below. Portions not listed in this section shall have no parking time restrictions unless specifically provided for in this chapter.

Street

Dixie Highway

Northbound portion between Requardt Lane and 24799 Dixie Highway

2 hours from 10:00 a.m. to 8:00 p.m.

North bound portion between 2479 **Dixies** Highway and Orphanage Road

30 minutes from 10:00 a.m. to 7:00 p.m.

#### SECTION II

All Ordinances or parts of Ordinances in conflict herewith are, to the extent of such conflict, if any, hereby repealed.

#### **SECTION III**

The Provisions of this Ordinance are severable and the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions

shall remain in full force and effect as long as they remain valid in the absence of that provision determined to be invalid.

## **SECTION IV**

This Ordinance shall be in full force and effect from and after its passage and publication according to law, and said publication may be in summary form.
